

WHEREAS, on November 9, 2009, the Court granted the parties' joint request for an extension of the discovery deadlines ("November Order") set forth in the Preliminary Conference Order entered May 19, 2008, as subsequently amended ("Preliminary Conference Order");

WHEREAS, the parties have been mindful of the discovery deadlines and have been working to complete discovery in accordance with the November Order;

WHEREAS, the parties have conducted depositions almost every week since depositions began in late July, including conducting two to three depositions during certain weeks, in an effort to complete depositions prior to the current discovery cut-off;

WHEREAS, on February 1 and 3, 2010, the parties completed the exchange of voluminous rebuttal expert reports, having submitted opening expert reports in December 2009.



WHEREAS, the parties have scheduled dates for expert witness depositions as follows:


WHEREAS, under the November Order, the deadline to file a Note of Issue is February 26, 2010;


